

# KollabMe Community Guidelines

Welcome to KollabMe! We are building the ultimate space for Artists, Producers, Engineers, and Venues to connect and create. To keep this community professional, safe, and productive for everyone, we ask that you adhere to the following guidelines.

## 1. Zero Tolerance for Child Sexual Abuse & Exploitation (CSAE)

KollabMe has a strict, zero-tolerance policy regarding the safety of minors. We are committed to protecting children from exploitation and abuse.

**Prohibited Content & Behavior:** You may not use KollabMe to engage in **Child Sexual Abuse and Exploitation (CSAE)**. This explicitly prohibits:

- **CSAE & CSAM:** The posting, sharing, solicitation, or promotion of any content that depicts Child Sexual Abuse and Exploitation (CSAE) or Child Sexual Abuse Material (CSAM).
- **Sexualization of Minors:** Any content that depicts a minor in a sexual manner or promotes the sexual exploitation of children.
- **Grooming & Sextortion:** Any behavior that targets minors for sexual exploitation, including "grooming" behaviors or building trust for sexual purposes.

**Reporting Protocol:** If we identify any content or behavior violating this policy, we will:

1. Immediately and permanently remove the content.
2. Permanently ban the user account and device.
3. Preserve evidence and report the incident to the **National Center for Missing & Exploited Children (NCMEC)** and relevant law enforcement agencies in compliance with 18 U.S.C. § 2258A and other applicable laws.

## 2. Professionalism & Respect

KollabMe is a professional network. Treat other creatives with respect.

- **No Harassment or Bullying:** We do not tolerate targeted abuse, stalking, or harassment of any user.
- **No Hate Speech:** Content that promotes violence or hatred against individuals or groups based on race, ethnicity, religion, disability, gender, age, or sexual orientation is strictly prohibited.

### 3. Intellectual Property & Copyright

As a platform for music professionals, we respect the rights of creators.

- **Original Work:** Only upload music, videos, and artwork that you own or have permission to use.
- **Copyright Infringement:** Accounts found repeatedly infringing on the intellectual property rights of others will be suspended or terminated.

### 4. Illegal Activities

You may not use KollabMe to facilitate illegal acts. This includes, but is not limited to:

- The sale of prohibited goods or substances.
- Fraud, money laundering, or scams.
- Solicitation of non-consensual sexual acts.

### 5. Enforcement & Reporting Mechanisms

We utilize a combination of automated detection tools and human moderation to enforce these rules.

- **In-App Reporting:** Users can report inappropriate content or behavior directly via the "Report" function located on every post and profile within the app.
- **Consequences:** Violations of these guidelines may result in content removal, temporary suspension, or permanent account termination.
